

WAIVER & RELEASE OF LIABILITY AGREEMENT

I fully understand and acknowledge that recreational and fitness activities have (a) inherent risk, dangers, and hazards and such exists in my use of any equipment and my participation in these activities; (b) my participation in or observation of others participating in such activities and/or use of such equipment may result in injury or illness including, but not limited to bodily injury, disease, strains, fractures, partial and/or total paralysis, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the representatives, employees, or volunteers of READY SET FUN, LLC, the negligence of the participants, the negligence of others, accidents, breaches of contract, or other causes; (d) by my participation in these activities and/or observation of other's use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages whether caused in whole or in part by the negligence or the conduct of the representatives, employees, or volunteers of READY SET FUN, LLC, (the "Releasees") or by any other person.

Releasees shall not be liable for any loss, damage or theft of any property of the undersigned, any participant, or others kept or stored in or about the Premises.

I, on behalf of myself, my personal representatives and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend, and indemnify and hold harmless the Releasees from any and all claims, actions or losses of bodily injury, property damage, wrongful death, losses of services or otherwise which may arise out of my use of any equipment or observation of other's participation in these activities.

I specifically understand that I am releasing, discharging, and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the Releasees.

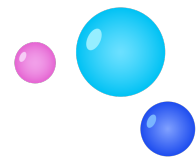
Parent or Legal Guardian Certification and Consent
